ERRATA CORRIGE PRESS RELEASE ISSUED ON 13/11/2015

Collegno (TO), November 16th 2015 - Prima Industrie S.p.A. states that the press release issued on 13/11/2015 included an incorrect information relating to the detail of net non recurring items, with impact on the consolidated EBITDA.

The correct sentence is the following: "To this regard it should be noted that EBITDA at 30/09/2014 benefited from a positive net non-recurring effect equal to 2,455 thousand euro; on the result at 30/09/2015 instead, nonrecurring items amount to -354 thousand euro and refer mainly to a revenue from sale of licenses equal to 1,260 thousand euro and to restructuring/reorganization costs, litigations and customers penalties equal to 1,614 thousand euro".

The company states that the above does not affect in any way the Group results as at 30/09/2015.

"The manager responsible for preparing the company's financial reports, Davide Danieli, declares, pursuant to paragraph 2 of Article 154-bis of the Consolidated Law on Finance, that the accounting information contained in this press release corresponds to the document results, books and accounting records".
