## WisdomTree Commodity Securities Limited (the "Issuer")

## Compulsory Redemption of WisdomTree Nickel 3x Daily Short Securities (the "Impacted Product")

The Issuer announced on 7 March 2022 that a Restrike Event occurred in respect of the Impacted Product. Due to continual movements in nickel prices on the 7 March 2022 (the "**Trading Day**"), the Calculation Agent has now determined that the Intra-day Price of the Commodity Contracts of the same class as the Impacted Product has fallen to or below zero during the Trading Day.

The Issuer has also now received notice from Merrill Lynch International and Citigroup Global Markets Limited that the Trading Day has been determined to be a Compulsory Pricing Date in respect of all of the Commodity Contracts of the same class as the Impacted Product and that therefore all of such Commodity Contracts have been terminated on the Trading Day with no payments due to or from the Counterparty from or to the Issuer. Accordingly the Impacted Product was automatically subject to a Compulsory Redemption on that day in accordance with Condition 8.8 of the terms and conditions on and subject to which Short and Leveraged Commodity Securities are issued.

The Redemption Amount of the Impacted Product available for distribution to the Security Holders has been calculated as zero.

As a result the Issuer requested on 7 March 2022 that the Impacted Product continues to be suspended from trading on both the ETFplus market of Borsa Italiana S.p.A and on the London Stock Exchange, and the Issuer will commence a process to delist the Impacted Product on those exchanges.

Terms used in this notice and not otherwise defined bear the same meanings as where used in the base prospectus of the Issuer dated 16 November 2021.
