We hereby refer to the Securities issued by the Issuer and the related Final Terms. Capitalised terms not otherwise defined in this notice will have the meanings ascribed to them in the Final Terms.

The Issuer informs you that on the 5th July 2013 it was resolved to redeem some of the ETCs issued by the Issuer and, as a consequence, hereby gives notice, in accordance with Condition 19 of the Terms and Conditions of the Securities, that it is electing to redeem, amongst the others, the relevant Securities which are currently traded on the ETFplus Market as they have demonstrated small levels of demand, as it is the intention of the Issuer to bring the offering of its securities in line with current and future investor demand.

The Issuer therefore informs the investors that it is electing to redeem the relevant Securities after 3 September 2013 (the "**Early Redemption Valuation Date**") in accordance with Condition 8(c) of the Terms and Conditions (such event an "**Issuer Call Redemption Event**").

As the consequence of the above decision, the relevant Securities will be delisted from the ETFplus Market organised and managed by Borsa Italiana S.p.A..

The last day of trading on the ETFplus Market organised and managed by Borsa Italiana S.p.A. will be the 27 August 2013 (included) and the Securities will be delisted on the 28 August 2013.
