News from ETFplus market

- 1 new ETF issuer: Fullgoal listed a Chinese bond ETF. Fullgoal is the first independent Chinese issuer to list a product on ETFplus
- 2 open funds new issuers: Eiger Sicav and Finlabo Investment Sicav listed their first open funds. At end of June 2016, 125 funds are listed on ETFplus market (22 issuers)

Trades (Jan - Jun 2016)

- Borsa Italiana has confirmed its leadership in Europe for number of trades on electronic platform with a market share of 32.60%, the ranking has been lead since 2005
- 2,683,643 trades with a turnover of €55.2bn


AUM/net inflow in Italy








Market spread




