We refer to the Fund which is an umbrella unit trust authorised by the Central Bank of Ireland pursuant to the European Communities Regulations (Undertakings for Collective Investment in Transferable Securities), 2011 (as amended).

We are writing to inform you that, owing to a recent request for a large redemption out of the Sub-Fund, European and Global Investments Limited (the "Manager"), as manager of the Fund, has formally taken the decision on the 28th April 2016 to terminate the Sub-Fund.

Accordingly, pursuant to Clause 36.03 of the Trust Deed of the Fund (available on the EGI website www.egifunds.com), notice is hereby given of the Manager's intention to redeem all Units in the Sub-Fund and to terminate it on 31.05.2016 (the "Final Dealing Day"). The Last Trading Day on the Secondary Market ETF Plus will be the 23.05.2016.

The Unitholder should, alternatively:

- Redeem the Units in the Class without charge in the usual manner on any Dealing Day up until the Last Trading Day (included) in accordance with the procedures set out in the Prospectus of the Fund.
- 2. Still remain as a Unitholder in the Sub-Fund on the Final Dealing Day. In this case, the Units will be automatically redeemed (at the Nav of Final Dealing Day) without charge. Following the Final Dealing Day, the net redemption proceeds will be returned to you by bank transfer in accordance with the provisions of the Prospectus


