MONDO TV GROUP executed its first production agreement with a North American producer of cartoons, Animagic Media owner of the property Bug Rangers for the production of a high quality series

The agreement, which was not included in the recent three years plan, is the first agreement of the kind with such size in the USA for Mondo TV

The agreement sets forth a participation by Animagic at 50% to production, and the sharing of revenues deriving from the exploitation of the series and the relevant licensing and merchandising in the same percentage

Rome, 14 April 2014 - Mondo TV and Animagic Media Group, a North American Entertainment Company that owns, develops, and produces animated intellectual properties, have reached an agreement for the co-production and distribution of a new 3D CGI animated TV series based on the successful Bug Rangers property.

The complete series will be composed of 26 episodes about 22 minutes each (or 52 of 11 minutes each) and is targeted for its debut at MipJunior in Cannes on October 2014 for the launch of its distribution.

The agreement provides for the participation of the parties at 50% each to the revenues deriving from the distribution of the series and its related licensing and merchandising, while Mondo TV will have a minority share on the revenues deriving from the toy line developed from the series. Mondo TV shall take care of the worldwide distribution of the series (except for North America) and shall distribute the licensing and merchandising in Southern Europe and Russia, while Lawless Entertainment will handle distribution of the series in North America as well as licensing and merchandising worldwide (except for Southern Europe and Russia).

The agreement, which was not included in the three years plan recently approved by the Board of Directors of the Company represents the first agreement of the kind with such size in the USA for Mondo TV.



Matteo Corradi, CEO of Mondo TV, stated: "We are really happy to be partnering with Animagic on this project, and we are keen to start working on such a beautiful property as Bug Rangers. We know we will work in great synergy with Animagic and together we will bring Bug Rangers to a worldwide success".

"Bug Rangers has a world class team with Lawless Entertainment and Mondo TV. Their combined experience, production and distribution prowess will deliver Bug Rangers to a global marketplace," says Roger Paglia, CEO of Animagic Media Group.

"Bug Rangers is already a proven success in the DVD market," says Cathy Malatesta, President of Lawless Entertainment. "This animated series will bring Squiggz, Cosmo and Flutter into the homes of children around the world."
