

CNH Industrial: Periodic Report on \$1 Billion Buyback Program

CNH Industrial N.V. (NYSE: CNHI / MI: CNHI) announces the conclusion of the \in 400 million component (the "First Component") of its \$1 billion share buyback program. The Company completed transactions in the period December 18, 2023 through December 29, 2023, reported in aggregate, as set forth in the table below. After the purchases announced today and considering those previously executed under the First Component, the total invested amount in the First Component is approximately \in 389,133,049.72 (\$423,804,057.13) or a total amount of 39,171,237 common shares purchased.
