**INFORMATIVA SU ACQUISTO AZIONI PROPRIE
NEL PERIODO 20 - 24 SETTEMBRE 2021**

Segrate, 27 settembre 2021 - Arnoldo Mondadori Editore S.p.A. (codice LEI 815600049A1F9AFE6666) comunica di aver acquistato sul Mercato Telematico Azionario, nel periodo tra il 20 e il 24 settembre 2021, n. 133.682 azioni ordinarie (pari allo 0,051% del capitale sociale) al prezzo unitario medio di euro 1,8226 per un controvalore complessivo di euro 243.654,57.

Tali operazioni sono state realizzate nell'ambito dell'autorizzazione all'acquisto di azioni proprie deliberata dall'Assemblea degli Azionisti del 27 aprile 2021 e in esecuzione del programma di acquisto a servizio dei Piani di Performance Share 2021-2023, 2020-2022 e 2019-2021, il cui avvio è stato approvato dal Consiglio di Amministrazione del 13 maggio 2021 (come da informativa resa in pari data anche ai sensi dell'art.144 bis del Regolamento Consob 11971/99 e dell'art. 5 del Regolamento UE 596/2014).

Segrate, 27 September 2021 - Arnoldo Mondadori Editore S.p.A. (LEI Code 815600049A1F9AFE6666) announces the purchase on the MTA (Electronic Stock Market), in the period from 20 to 24 September 2021, of no 133,682 ordinary shares (equal to 0.051% of the share capital) at an average unit price of €1.8226 for a total amount of €243,654.57.

These transactions were made under the authorization to purchase treasury shares approved by the Shareholders' Meeting of 27 April 2021, and as part of the purchase programme to service the 2021-2023, 2020-2022 and 2019-2021 Performance Share Plans, the start of which was approved by the Board of Directors on 13 May 2021 (as per the disclosure made on the same date also pursuant to Article 144 bis of CONSOB Regulation 11971/99, and to Article 5 of EU Regulation 596/2014).
