BFF notifies the execution and the completion of the shares' buy-back programme

Milan, 18th October 2021 – BFF Bank S.p.A. (“BFF” or the “Bank”) announces to have purchased, in the period between 14th October and 15th October 2021, 20,000 ordinary treasury shares, equal to 0.0108% of the 185,267,073 issued shares, for a total amount – fees excluded – of Euro 147,550.00, within the shares' buy-back programme, whose launch was resolved by BFF's Board of Directors on 28th September 2021¹, after obtaining the issuance of the prescribed authorization by the Bank of Italy on 21st September 2021, and in execution of the resolution of BFF's ordinary Shareholders' Meeting of 25th March 2021.

Purchases were executed by the authorised intermediary Mediobanca S.p.A..

The aggregate of the daily buy-back transactions on Euronext Milan (former *Mercato Telematico Azionario* – MTA) managed by Borsa Italiana S.p.A. is reported below, and the detail of such transactions executed in the aforementioned dates is enclosed.
