### Cessione di azioni proprie

("NDT" o la "Società"), tra i principali operatori europei nella produzione di carte decorative per pannelli nobilitati e del flooring utilizzati nel settore dell'interior design, quotata nel segmento STAR, organizzato e gestito da Borsa Italiana S.p.A., comunica di aver perfezionato in data odierna la cessione in blocco ad investitori istituzionali, di n. 120.000 azioni proprie, ovvero della totalità della azioni proprie possedute della Società, al prezzo di euro 4,36 per azione (con uno sconto del 5% sulla media dei prezzi di chiusura dei giorni 29, 30 Settembre e 1 Ottobre 2021), per un corrispettivo complessivo di euro 523.200.

Per l'effetto, a seguito di tale cessione, la Società non detiene ulteriori azioni proprie ed il flottante si attesta al 38,4%.

### Sale of treasury shares

("NDT" or the "Company"), one of Europe's top players in the production of decorative papers for laminated panels and flooring used in interior design, listed in the STAR segment organized and managed by Borsa Italiana S.p.A., announces the completion today of the bulk sale, to an institutional investor, of no. 120,000 treasury shares, i.e., all the treasury shares held by the Company, at a price of € 4.36 per share (with a rebate of 5% on the average of the closing values for September 29, 30, and October 1, 2021), for a total consideration of € 523,200.

Following the disposal, the Company does not hold any additional treasury shares and the free float amounts to 38,4%.
