Milan, September 19, 2022 – Webuild S.p.A. informs that it has purchased, in the week of September 12-16, 2022 included, no. 171,513 ordinary treasury shares (LEI: 549300UKR289DF4UXQ47), at an average price of Euro 1.3917 per share, for a total value of Euro 238,707.73 as part of the purchase authorization approved by the Shareholders' Meeting on April 28, 2022.

The purchases were made through the intermediary Intermonte S.p.A.
