Both parties may terminate this agreement at any time by giving the other party at least 90 days written notice.

Any request by the Service Facilitator/Redistributor for repayment of overpaid Service Facilitator Redistribution Licenses, based on an inaccurate Service Facilitator Application, must be made within three calendar months after the date the Service Facilitator/Redistributor signed the Application. The Service Facilitator/Redistributor is only entitled to credits within that three month period.
